WVU Collaborative Internal Seed Funding - In a collaborative effort, the Offices of Research, Global Affairs and the Energy Institute are pleased to announce an internal seed funding program to encourage research with an international dimension. For the first program year, the selected topical area will be energy. This includes projects that are exclusively energy and those with a partial emphasis on energy, examples include: energy/water; energy/food; energy policy/law or energy finance/management, and energy security. Our intention is to provide funding, awarded on a competitive basis, as a stepping stone to transition the international research effort to sustained external support. Three awards up to \$20,000 are expected. The program seeks to: Develop collaborations with foreign institutions including private industry and foreign laboratories; preference will be given to efforts targeting the Middle East, Latin America and Asia; Stimulate new areas of inquiry; Advance research efforts leading to publication and national/international presentations; Increase the visibility, especially internationally, of WVU research; And to support activities leading to external funding. NSF Smart & Connected Health - The goal of this solicitation is to support strongly interdisciplinary, integrative research and research capacity-building activities that will improve understanding of smart and connected communities and lead to discoveries that enable sustainable change to enhance community functioning. Unless stated otherwise, for the purposes of this year's solicitation, communities are physical, geographically-defined entities, such as towns, cities, or incorporated rural areas, consisting of various populations, with a governance structure and the ability to engage in meaningful ways with the proposed research. Successful S&CC projects are expected to pursue research and research capacity-building activities that integrate multiple disciplinary perspectives and undertake meaningful community engagement, and to include appropriate and robust evaluation plans for assessing activities and outcomes. Successful proposals will, within the financial resources provided by the award, construct such databases and/or relevant analytic techniques and produce a finished product that will enable new types of data-intensive research. The databases or techniques should have significant impacts, either across multiple fields or within broad disciplinary areas, by enabling new types of data-intensive research in the SBE sciences. MSHA Mine Health and Safety Grants - The Secretary of Labor's vision for the U.S. workforce is Promoting and Protecting Opportunity. One of the Department's strategic goals is to "improve workplace safety and health" through the strategic objective "secure safe and healthy workplaces, particularly in high-risk industries." MSHA's goal in accomplishing this objective is to "prevent death, disease, and injury from mining and promote safe and healthful workplaces for the Nation's miners." Under Section 503 of the Federal Mine Safety and Health Act of 1977 (Mine Act), Public Law 95-164, as amended, the Secretary of Labor through the Mine Safety and Health Administration (MSHA) may award grants to States to include the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, American Samoa, Guam, and the Commonwealth of the Mariana Islands to assist them in developing and enforcing State mining laws and regulations, to improve State workers' compensation and mining occupational disease laws and programs, and to improve safety and health conditions in the Nation's mines through Federal-State coordination and cooperation. Cutting-Edge Basic Research Awards (CEBRA) (R21) - The National Institute on Drug Abuse (NIDA) Cutting-Edge Basic Research Award (CEBRA) is designed to foster highly innovative or conceptually creative research related to drug abuse and addiction and how to prevent and treat them. It supports research that is high-risk and potentially high-impact that is underrepresented or not included in NIDA's current portfolio. The proposed research should: (1) test a highly novel and significant hypothesis for which there are scant precedent or preliminary data and which, if confirmed, would have a substantial impact on current thinking; and/or (2) develop or adapt innovative techniques or methods for addiction research, or that have promising future applicability to drug abuse research. DOJ Research on Reducing Violence in Community - This solicitation will focus on supporting research designed to build knowledge on what it takes to produce sustained community-level reductions in violence. Proposed studies should examine multiple factors, including but not limited to explicit violence prevention initiatives, that may play a role in preventing or reducing violence in a community for an extended period of time. Besides violence prevention initiatives, research should examine factors such as community infrastructure and resources (e.g., access to health care, amount of public housing), local laws and policies (e.g., juvenile curfew laws, police patrol strategies), community norms (e.g., perspectives on carrying a firearm, trust in law enforcement), shared community experiences/beliefs (e.g., exposure to trauma, subject to implicit bias), and collaboration among organizations/agencies working in the community. NIJ FY17 Research and Evaluation in Safety, Health and Wellness in the Criminal Justice System - The purpose of this solicitation is to promote multidisciplinary research in the area of safety, health, and wellness for the criminal justice community in support of the NIJ Safety, Health, and Wellness Strategic Research Plan 2016-2021. Applicants should submit proposals that address one of the three categories identified below. Application titles should clearly indicate the category proposed. Each category aligns with specific objectives within the Safety, Health, and Wellness Strategic Research Plan. Applicants should note that each category seeks to improve health and wellness in specific populations using different researcher strategies and goals. Category 1 seeks applicants using behavioral, psychological and physiological measures related to mental and physical health. Category 2 seek applicants to study the impact of the criminal justice system on families and child development. Category 3 seeks to address policy related to courts and the criminal justice system.
