## **Faculty Research Opportunities**

WVU Collaborative Internal Seed Funding - In a collaborative effort, the Offices of Research, Global Affairs and the Energy Institute are pleased to announce an internal seed funding program to encourage research with an international dimension. For the first program year, the selected topical area will be energy. This includes projects that are exclusively energy and those with a partial emphasis on energy, examples include: energy/water; energy/food; energy policy/law or energy finance/management, and energy security. Our intention is to provide funding, awarded on a competitive basis, as a stepping stone to transition the international research effort to sustained external support. Three awards up to \$20,000 are expected. The program seeks to: Develop collaborations with foreign institutions including private industry and foreign laboratories; preference will be given to efforts targeting the Middle East, Latin America and Asia; Stimulate new areas of inquiry; Advance research efforts leading to publication and national/international presentations; Increase the visibility, especially internationally, of WVU research; And to support activities leading to external funding. **Application Due** Date: February 15, 2017. **NSF Cybersecurity Innovation for Cyberinfrastructure (CICI)** program-- to develop, deploy and integrate security solutions that benefit the scientific community by ensuring the integrity, resilience and reliability of the end-to-end scientific workflow. This solicitation seeks unique ways to protect scientific instruments, resources, cyberinfrastructure and data that extend beyond building better perimeters and point solutions. As funding agencies move toward providing openly accessible data, the

possibilities for scientists and engineers to use data sources beyond those created by their own community grow. The scope of the scientific workflow encompasses instruments, mobile and traditional networks, processing software, analysis tools, computing and storage resources as well as information repositories and data archives. In order to produce accurate results, each data source must be identifiable and trustworthy. Systems must guarantee that data sets cannot be altered, which could potentially modify the analytic outcomes. Funded activities under CICI should identify opportunities for student engagement as well as cybersecurity education and training. Proposals that demonstrate opportunities to engage students directly in the deployment, operation, and advancement of the CICI-funded activities are welcome. **Full Proposal Deadline Date: March 1, 2017**

NIJ FY17 Research and Evaluation in Safety, Health and Wellness in the Criminal Justice System - The purpose of this solicitation is to promote multidisciplinary research in the area of safety, health, and wellness for the criminal justice community in support of the NIJ Safety, Health, and Wellness Strategic Research Plan 2016-2021. Applicants should submit proposals that address one of the three categories identified below. Application titles should clearly indicate the category proposed. Each category aligns with specific objectives within the Safety, Health, and Wellness Strategic Research Plan. Applicants should note that each category seeks to improve health and wellness in specific populations using different researcher strategies and goals. Category 1 seeks applicants using behavioral, psychological and physiological measures related to mental and physical health. Category 2 seek applicants to study the impact of the criminal justice system on families and child development. Category 3 seeks to address policy related to courts and the criminal justice system. Categories: 1) Causes and effects of stress and trauma on (a) law enforcement and corrections officers or (b) individuals in violent communities; 2) Impact of parental jail incarceration on children; and 3) The efficacy of services, strategies, policies and processes within the criminal or juvenile justice system that serve as responses to children exposed to violence.
