

Summary of Activities

Data and Methods



This quarter focused on continued analysis of Aim 1 data, collection of Cohort 1 post measures (surveys + process evaluation, Fitbits, FitnessGram), and data entry/cleaning. Post-surveys were submitted by 11 of 19 families in the control group (57.9%), 33 of 55 in the school intervention group (60.0%), and 27 of 51 in the family intervention group (47.1%), 31 of 32 classroom teachers (96.9%), 14 of 18 PE teachers (77.8%), and 11 of 13 principals (84.6%). In addition, Cohort 2 recruitment was conducted, committed Cohort 2 schools were notified of study arm assignment, and 4th grade FitnessGram results collection begun.

Research to Policy (R2P) Advisory Council
