Summary of Activities

Data and Methods

Aim I

Data entry was completed and the initial analysis reviewed. We conducted a preliminary literature review to assess which school level variables are appropriate for the next phase of analysis and potential manuscript development. We are also reviewing policy and measurement at the state level to determine next steps for analysis and interpretation.

Aim 2

This quarter focused on review of completeness of consents of participants, baseline data collection (survey, Fitbit), and start of school and family interventions. Final student/parent participant numbers include 133 in the family intervention (5 schools), 75 in the school intervention (4 schools), 113 in the control intervention (4 schools), and 40 school personnel (22 classroom teachers, 10 PE teachers, and 8 principals).
