Summary of Activities

Data and Methods

Aim I

The Aim 1 2013-2014 and 2014-2015 statewide databases have been updated with more current/detailed National Center for Education Statistics (NCES) data that recently became available and % Needy data from the West Virginia Department of Education (WVDE); data dictionaries were updated accordingly. The supplemental PE and Principal online surveys databases have been reviewed and prepped for analysis, and data dictionaries developed. Two manuscripts are being developed based on these data; one addressing recent Physical Education (PE) and Physical Activity (PA) practices in WV elementary schools and the second comparing student health and academic outcomes based on school practices.

Aim 2

Data meeting, begun in June 2017, continues as needed to coordinate/track progress of survey entry/database storage for the excitingly huge amount of data accumulating for analysis. Cohort 3 organization was finalized with 6 participating schools, prep of recruitment and baseline materials, and timeline planning. Final Cohort 3 schools roster includes 3 control (Wood – Blennerhassett, Martin; Jackson - Evans), 2 school intervention (Wood – Waverly; Jackson – Kenna), and 1 family intervention schools (Wood - Fairplains).

Aim 3

Research briefs/thank you notes were mailed to principals of Cohort 1 & 2 schools. These briefs had overall information and school level information on them about how many participants they had for their schools. Success Stories contact began with calls made to parent/school personnel participants who provided positive comments on surveys. The sustainability project, an outgrowth of the success stories was developed and approved by IRB, with surveys mailed to Family Intervention parents and School Intervention classroom teachers in September. Community Partnership Board (CPB) feedback was used in development of both the success stories and sustainability projects.
